

# YOUR CHOICE BARNET CARE WORKERS CAMPAIGN

## ***WHY WE ARE STRIKING***

- ***To protect services for people with disabilities***
- ***For Fair Pay for the work we do***
- ***To bring this Frontline service back into the Council***

### **Background:**

In February 2012 Barnet Council transferred Learning Disability and Physical and Sensory Impairment services for adults to a Local Authority Trading Company (LATC) called Your Choice Barnet (YCB). Already in 2012 profound financial difficulties were identified to the tune of £1million, which is one fifth of its overall budget. YCB took out a commercial loan from Barnet Homes which it will be repaying with 6% interest. In the space of 18 months preceding this dispute there have been two attacks on our members terms and conditions and over 30 members of staff (a sixth of the workforce) have taken redundancy. Intensive talks with Barnet UNISON and YCB and 4 days of strike action failed to bring about a better “offer” than a 7.9% wage cut. An offer our members felt they could only refuse. It became clear that the 100% owner of YCB, Barnet Council, really pulls the financial strings for YCB and has conveniently handed on the responsibility of Barnet Council’s pension deficit for the transferred staff to YCB. YCB would not have to make this pay cut if it did not have to cover the cost of the pension deficit created by Barnet Council.

This is not consistent for other contracted services. NSL, a private company, is not being saddled with financing the pensions’ deficit.
